In total, 7,953 people have given their life to Christ, and our readership now stands at 2.85 Million across 78 languages.



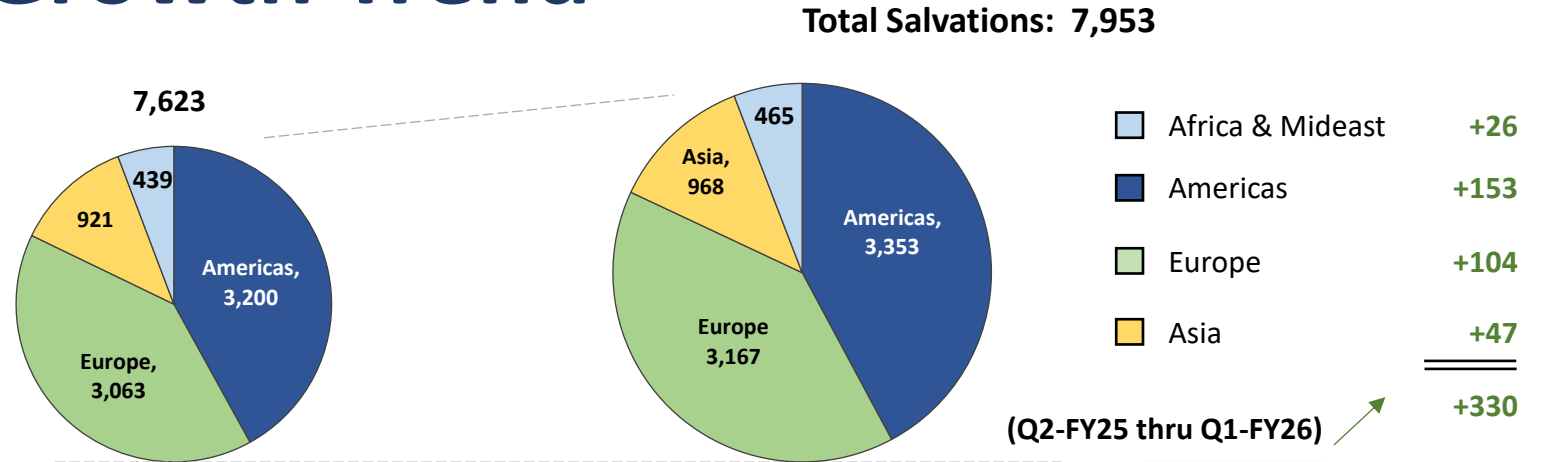
# Global Impact & Growth Trend

(Cumulative thru Q1-FY2026)

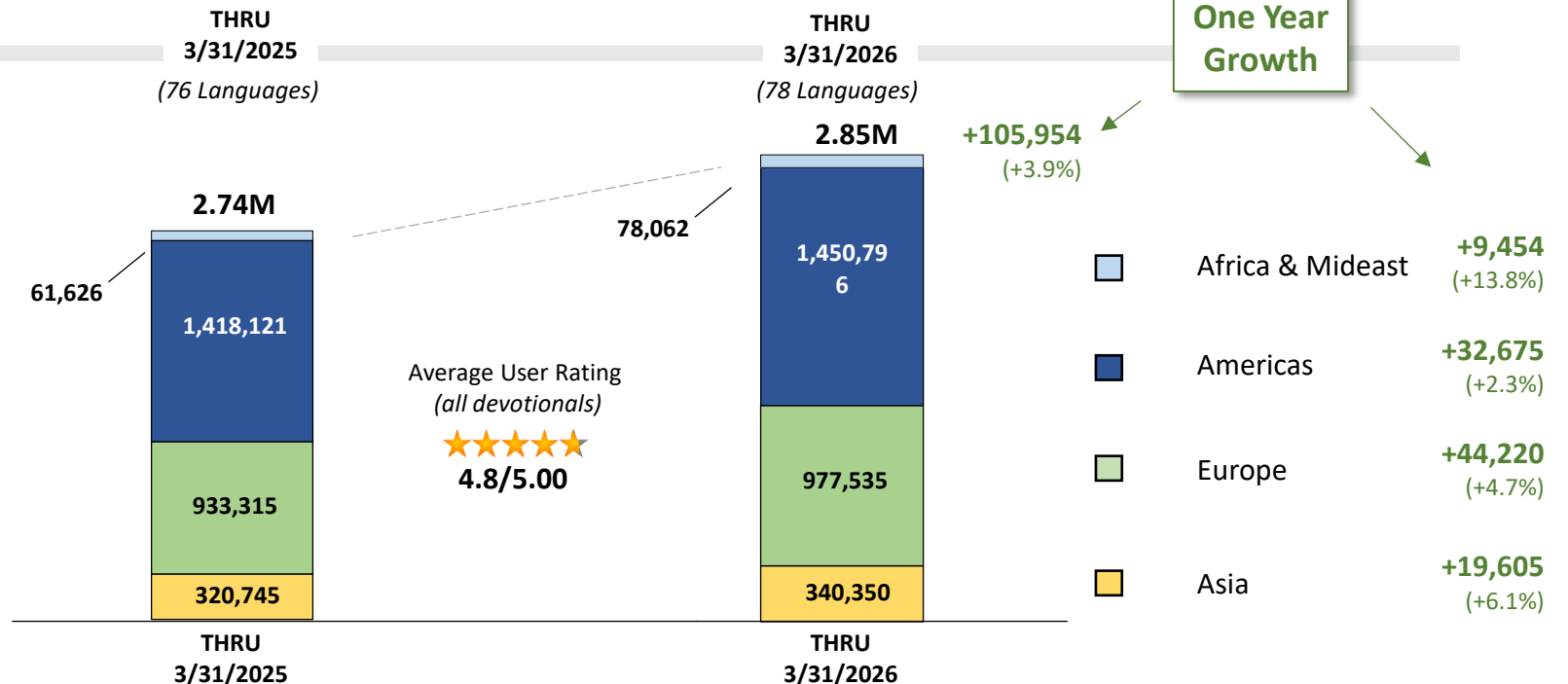
## TOTAL SALVATIONS (Cumulative)

Over the past 12 months, Twenty20 Faith has provided ministry to people in 198 Countries worldwide.

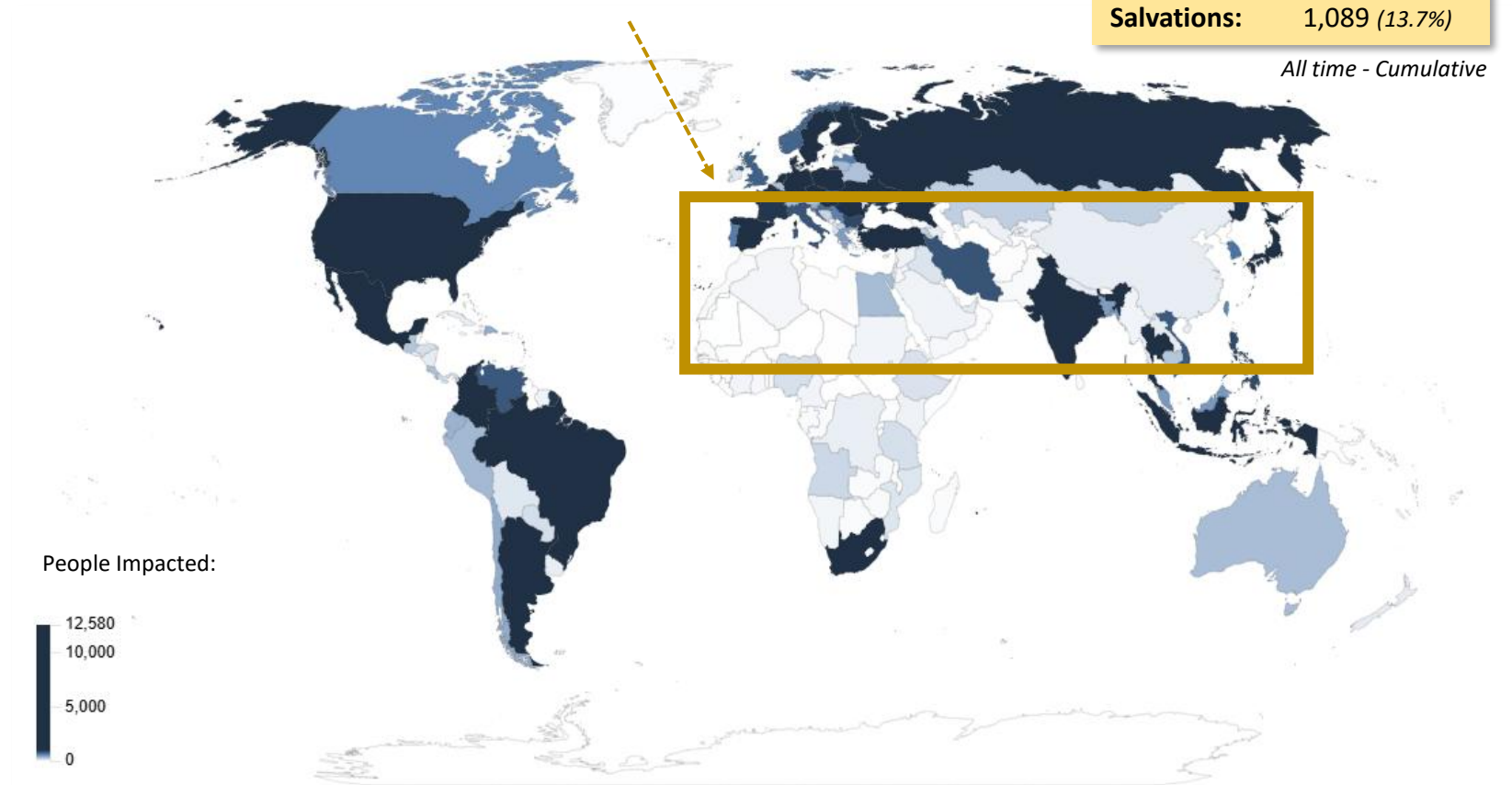
Through God’s favor and blessing, Twenty20 Faith has had substantial reach and impact into some of the more challenging areas of the world, including the “10/40 Window”.

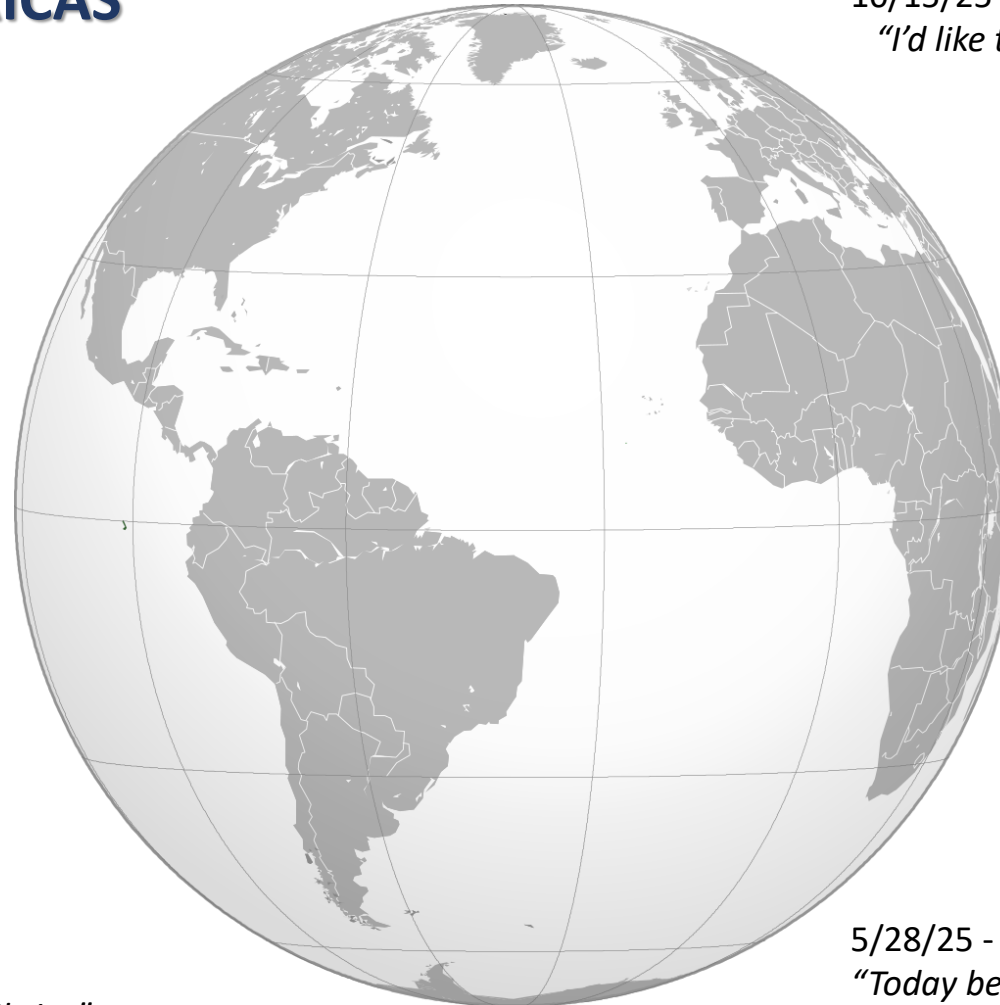
